## Huon Valley Council Temporary Disability Parking – Fact Sheet

- The Huon Valley Council has adopted the temporary parking permit scheme to assist locals access services within the community.
- This is a free service provided to members of the community.
- The Huon Valley Council is aware that members of our community can face periods of temporary incapacity in relation to ambulatory functionality.
- This permit is to be used to assist our community to retain their day to day functionality and quality of life.
- The permit however, is temporary in nature.

### How to Apply for a Temporary Disability Parking Permit

- Please complete the attached Application Form and have the Form endorsed by your current Medical Practitioner or Qualified Health Care Professional.
- Return the completed form together with the endorsed signature to the Customer Service Centre Huon Valley Council located at 40 Main Street Huonville.
- The Customer Service Centre will issue you with a Permit with an endorsed date.

### Where to use your Temporary Disability Parking Permit

This Permit is only valid for Huon Valley Council Car Parks

- (i) Sale Street Huonville
- (ii) Brady Street Geeveston
- (iii) Mary Street Cygnet
- (iv) Behind Town Hall, Cygnet

To obtain the above parking concession, members will need to clearly display their permit so that it is visible throughout the windscreen of the vehicle.

This permit allows the bearer to park in Disability Signed Parking Council Zones only.

This permit does not allow the bearer to park in DIER road signed disabled parking zones.
