1 EXECUTIVE SUMMARY

This community engagement was conducted at the "Consult Level" in accordance with Council's Community Engagement Framework.

For the purposes of the engagement, feedback on the proposed project was invited from the community for a period of three weeks (5 May 2020 to 24 May 2020).

Due to the current COVID-19 restrictions, Council was unable to provide hard copy surveys or have an on-site meeting, however signage and posters were displayed in the Franklin area.

Community received notification via email and the Council eNewsletter. A total of 1,148 recipients received the eNewsletter over the three-week period.

This report summarises feedback received throughout the engagement period. A total of 89 responses to the request for feedback were received and 3 submissions were received via Council email. Copies of each of the responses received are included in Appendix 1 of this report.

2. BACKGROUND

The Franklin foreshore area has been a focal point for rowing, cricket, football, cycling and other sports since the 1800's and is strongly linked with the early history of Franklin's settlement and the development of the Huon Valley.

This master plan will allow Council to plan for future development of the area and will be able to seek funding when available.

The purpose of this project is to:

- promote the use of the Franklin foreshore area and support measures to increase community access to the foreshore and create a sporting precinct that can be enjoyed be the community, recognising the history of the area.
- improve pedestrian access from the existing walking track to the Franklin Oval.
- Provide improved sports facilities including cricket training nets, handball court and tennis rebound wall.

Community members were invited to share their feedback about the proposed master plan, their use of the area, their age bracket and what other elements they would like to see in the future. The survey also provided community members with an opportunity to be kept 'up-to-date' on this project by including their email address.

3. ENGAGEMENT FEEDBACK

Community members have volunteered considerable time to consider the project and provide feedback. It is acknowledged that due to opposing and diverse community views, there will be some community members who will disagree with the project design.

Key stakeholder groups were identified prior to the consultation process, with targeted engagement undertaken with:

- Southern Tigers Cricket Club
- Franklin Bowls Club

As indicated in the Summary to this Report a total of 89 responses via the survey and 3 emailed submissions to the request for feedback were received during the engagement period. A copy of the survey responses is included as Appendix 1.

The following key themes where noted throughout the consultation:

Location of cricket nets

Council consulted with the Southern Tigers Cricket Club regarding a location for new cricket training nets. It was agreed that consideration would be given to the direction of the ball and sun direction and the location as per point 4 on the draft plan was identified.

- Direction of ball this location would allow for the ball to be hit back into the oval and would not interfere with pedestrians and vehicles within the immediate area.
- Direction of sun cricket training nets should have a north-south orientation, or a maximum of 30 degrees east or west of north (for practice pitches only). The latter requirement is particularly important for the safety of players as training is usually conducted in the later afternoon or evening when the sun is setting. (Community Cricket Guidelines Australia)

Asbestos

Concerns were raised regarding the site of the old clubrooms and the possible contamination of the area. There have been two independent reports by suitably qualified person on this site regarding asbestos, and both confirmed there is no threat to the public from asbestos. The site however does continue to be a source of public concern.

The cricket nets were identified as an element to be included in this plan following ongoing discussions with the cricket club to upgrade the nets. Having the cricket nets and the handball court covering the site would help alleviate community concerns. The site was rehabilitated as per the recommendations to cap the site with gravel and install a barrier that would eliminate vehicles passing over the site both of these measures were adopted at the time.

Velodrome

It is noted a number of responses raised the concern with the removal of the velodrome.

The velodrome has been in place since Franklin Athletic Club was formed in 1946. An active sprint cycling club has not existed in the Huon Valley since 1974-75. The current condition of velodrome is poor and whilst it is recognised the velodrome has had some interest of late from a local group of riders the condition of the velodrome requires considerable, and cost estimates to repair the velodrome to a minimum standard have been prepared.

The costs to repair are estimated to be in the range of \$250,000 to \$500,000. These are indicative costs and have not been fully scoped. Council would need to undertake a tender process to complete this work.

The concept plan does not propose to remove the velodrome slope but it does propose a cutting of the velodrome of approx. 5 metres in length to enable the cricket nets to be constructed beside the ground and the bowlers run up to be from the oval, removal of the remaining seal and replacing with grass. The construction of the nets whilst it will interrupt the track, casual riders will still be able to ride around the oval with the ability to drop down onto the flatter area and decline to the slope once past the nets. It could be proposed that the net cut in could be the start and stop section of the track.

The concept plan proposes the removal of the sealed material however it will be subject to funding to replace the seal with a grassed velodrome area as seen at Ranelagh Recreation Ground. This grassed area also provides a welcoming viewing point for cricket and football spectators.



Franklin

Walking Track

The engagement survey included a specific question requesting feedback on the preferred construction material for the walking track; Gravel or formal exposed aggregate concrete. As can be seen by the survey results in appendix 1 there was 40 responses who preferred gravel material and 49 responses who preferred the exposed aggregate concrete.

Due to the funding available to implement the plan, and the ensure as many elements of the plan can be implemented, it will be recommended that given the close number of responses received, a gravel path be included in the revised plan. This will enable other elements that where a higher priority to be completed.

Public Art

It has been recommended by the community that installation of public art would be a benefit the site and celebrate the rich sporting history of the area. This would be subject to future grant funding but will be considered as part of the implementation plan.

Interpretive history signage – History timeline

Franklin township has a rich history and already celebrates this through the Franklin Historic Walk which incorporates interpretative signage along the foreshore. A suggestion included in the feedback included a timeline history of Franklin be engraved onto the timber bollards along the foreshore. This will be a consideration of the implementation plan and will involve engagement with the Franklin History Group and the Arts and Culture Committee.

Seating and shade

It is noted throughout this consultation that there are community desires for more seating and shade. This will be incorporated into the final designs and implementation plan.

Continued vehicle access to foreshore

Concerns have been raised throughout the consultation regarding the potential closure of vehicle access along the foreshore. It has been identified that access is required for rowing events and also if the Huon Highway was closed, with an opportunity for the foreshore to be used as a bypass. It is noted removable bollards will be installed along the foreshore to enable maintenance vehicles and diverted access if required.

Relocation of Cenotaph

Comments have been noted suggesting that future consideration be given to the relocation of the Cenotaph located on the Huon Highway to a more suitable location within the oval precinct. Council agrees that this idea could be a benefit to the community and has identified it as future project. Further consultation will be required with the community and the RSL as the key stakeholders before any decision is made on this suggestion.

Multi-use court for basketball/handball/netball

It is noted that a number of responses have suggested the construction of a multi-use court instead of a hand-ball court. This suggested has been adopted and is now reflected in the new revised plan with a half court incorporating a tennis rebound wall, handball court and a basketball hoop.

The emailed submissions raised the following comments:

The Franklin Bowls Club

A submission was received from The Franklin Bowls Club and is included as Appendix 2. The club referred to two points as they appear on the Draft Franklin Master Plan Stage 3 – Sporting Precinct.

Point 1 "Improve the visual amenity of the area by painting elements of the club rooms facing the walking track"

The Club has no objection to the painting of that portion of the clubrooms & shed facing the walking track and offered a suggestion that the Franklin Primary School be approached with a view to the school designing & implementing a mural on one or both walls.

Point 2 "Improve vehicle control by defining existing car parking area around the Bowls and Tennis Club and restrict vehicle access to the foreshore"

- Parking There should be no parking in front of the Club's gate facing the Franklin Oval, and this area should be marked as such.
- For the parking spaces adjacent to the northern side of the Club, the Club desires a means being provided to restrict parking to 'Bowls Club parking only' on interclub competition days. During major rowing carnivals the Club's members & visiting team have great difficulty in finding available parking adjacent to the Club.
- The drain behind the parking area on the northern side of the Club should be removed.
- Access to the back gate between the clubrooms & shed must be maintained.
- Parking should remain available adjacent to the back of the shed as it is closest to the back gate.

All comments raised by the Franklin Bowls Club will be key considerations of the projects implementation plan.

Resident A

A submission was received from a local resident which raised a number of matters including the cricket net location and the asbestos. A copy is included as Appendix 3.

Cricket Nets

The resident is not opposed to the construction of the cricket nets but has raised concerns regarding the location on the draft plan which included the removal of a section of the velodrome.

The Southern Tigers Cricket Club identified the need for suitable training nets and asked Council for assistance in addressing this important issue. Having suitable practice wickets will allow the Club to provide intensive training for batting, bowling and wicket keeping, which the Club cannot do solely from centre wicket drills. The Council has been engaging with the club to support the upgrade of the cricket facilities at the Franklin Oval for a number of years, this includes lodging grant applications for the work. The proposed site is considered to be the only suitable location for training nets, that meet the Cricket Association Guidelines.

Asbestos

The resident raised concerns regarding the site of the former clubrooms and contamination of the area.

There have been two independent reports by suitably qualified people on this site regarding asbestos, and both confirmed there is no threat to the public from asbestos. The site however does continue to be a source of public concern.

The cricket nets were identified as an element to be included in this plan following ongoing discussions with the cricket club to upgrade the nets. Having the cricket nets and the handball court covering the site would seal the area of permanently and help alleviate community concerns.

Public Art

The submission suggested that is an ideal site for a high-quality piece of public art.

It was also recommended by the community that installation of some public art would benefit the site and celebrate the rich sporting history of the area. The project team will engage with the Council's Art and Culture Committee and the Franklin History Group regarding public art. It is seen that this has potential for grant funding in the future.

Former Clubrooms Scoreboard

It was suggested to investigate the use of the former scoreboard in an historic interpretation of the site.

The project team will engage with the Council's Art and Culture Committee and the Franklin History Group regarding public art. It is seen that this has potential for grant funding in the future.

Other Elements

- 1. Painting of rear of Bowls Club no objection but should be a matter for that Club
- 2. Vehicle access should remain along the foreshore. However, access across the former club rooms site (i.e east of the Bowls Club) should be prevented.
- 3. Car parking and road and gutter treatments should remain informal.
- 4. Removal of boundary fence and section of velodrome oppose strongly.
- 5. Cricket nets (see above)
- 6. Picnic tables, grassed areas and shade trees support strongly
- 7. Walking track formalised not needed and is a waste of money.
- 8. Entrance sign strongly opposed. Interpretation panels and design of the precinct should tell the story. Sign would also be in the way of vehicle traffic.
- 9. Interpretation panels strongly support but needs to be done well.
- 10. Rowing Statue and panels no objection but should be a matter for the rowing club to pursue.
- 11. Asphalt removal I note that Southern Pedals previously proposed to fund an upgrade the surface of the track but Council preferred the track to degrade. However, the track is beyond retrieving and I reluctantly support the asphalt removal. However, the historic banking must be retained in its entirety.

12. Handball court – there should be a range of sports and games provided but the focus should not be just to concrete over the contaminated site. Could include public exercise equipment, etc.

All comments raised by the resident will be taken into consideration during the implementation plan.

Franklin Progress Association (FPA)

A submission was received from the Franklin Progress Association which raised several matters. A copy is included as Appendix 3.

Cricket Nets

There is broad agreement on the provision of upgraded cricket nets although the FPA does not have an agreed preferred location. However, in addition to the proposed site it is requested that Council also consider other locations for the nets including:

- 1 the north-east corner of the oval and
- 2. immediately adjacent to the existing tennis court.

It is further requested that Council provides an in-house cost/benefit analysis to the community on each of these three sites.

The Southern Tigers Cricket Club identified the need for suitable training nets and asked Council for assistance in addressing this important issue. Having suitable practice wickets will allow the Club to provide intensive training for batting, bowling and wicket keeping, which the Club cannot do solely from centre wicket drills.

The Council has been engaging with the club to support upgrade of the cricket facilities at the Franklin Oval for a number of years, this includes lodging grant applications for the work. The proposed site is considered to be the only suitable location for training nets, that meet the Cricket Association Guidelines.

Velodrome

There is broad agreement on the requirement to remove the asphalt from the former velodrome. However, it is our preference that the entirety of the velodrome banking is retained.

It is noted a number of responses raised the concern with the removal of the velodrome.

grass. The construction of the nets whilst it will interrupt the track, casual riders will still be able to ride around the oval with the ability to drop down onto the flatter area and decline to the slope once past the nets. It could be proposed that the net cut in could be the start and stop section of the track.

The concept plan proposes the removal of the sealed material however it will be subject to funding to replace the seal with a grassed velodrome area as seen at Ranelagh Recreation Ground. This grassed area also provides a welcoming viewing point for cricket and football spectators.

Asbestos

There is a high degree of concern over the treatment of the asbestos presence. It is our view that prior to any works that all contaminated materials be removed and disposed of properly and the site be fully rehabilitated. If Council chooses not to do this then we request that it provides an in-house cost/benefit analysis of both options to the community.

There have been two independent reports by suitably qualified personal on this site regarding asbestos, and both confirmed there is no threat to the public from asbestos. The site however does continue to be a source of public concern. The cricket nets were identified as an element to be included in this plan following ongoing discussions with the cricket club to upgrade the nets. Having the cricket nets and the handball court covering the site would help alleviate community concerns. The site was rehabilitated as per the recommendations—cap the site with gravel and install a barrier that would eliminate vehicles passing over the site both of these measures were adopted at the time.

Comment noted regarding cost analysis

Other Elements

- There is strong support for the provision of shade trees, benches and tables and of softening the surfaces in this precinct. It is noted that public art could also be included.
- There is strong support for the addition of interpretation panel(s).
- We note the limited use of the public toilets adjacent to the change rooms and recommend the provision of improved signage.
- We do not support the removal of access for vehicles along the foreshore.
- We do not support the provision of an Overhead Gateway Sign.


All comments raised by the Franklin Progress Association will be taken into consideration during the implementation plan.

4. RECOMMENDATION


Based on the feedback and suggestions received, amendments have been made to the Draft Master Plan as follows:

- d) Handball court be included in multi-use court with tennis rebound wall and basketball hoop (12)

Pursuant to the Club's Committee meeting of 3 February 2020, the Club makes the following comments:

Regarding point 1 "Improve the visual amenity of the area ..."

- The Club has no objection to the painting of that portion of the clubrooms & shed facing the walking track so long as the Club approves of the painting scheme and there is no cost to the Club.
- The Club suggests that the Franklin Primary School be approached with a view to the school designing & implementing a mural on one or both of the walls.

Regarding point 2 "Improve vehicle control by defining existing car parking ..."

- There should be no parking in front of the Club's gate facing the Franklin Oval, and this area should be marked as such.
- For the parking spaces adjacent to the northern side of the Club, the Club
 desires a means being provided to restrict parking to 'Bowls Club parking
 only' on interclub competition days. During major rowing carnivals the Club's
 members & visiting team have great difficulty in finding available parking
 adjacent to the Club.
- The drain behind the parking area on the northern side of the Club should be removed.
- Access to the back gate between the clubrooms & shed must be maintained.
- Parking should remain available adjacent to the back of the shed as it is closest to the back gate.

Although not directly relevant to the Club, the Committee suggests that it would be unwise to "... restrict access to the foreshore." in view of this access providing an alternative route through Franklin in the event of the closure of the Huon Highway due to some emergency or other need.

The Club appreciates being given the opportunity to comment on the proposed walking track and looks forward to further consultation with Council.

Cricket Nets

I support the provision of upgraded cricket nets for club and community use. However, I strongly oppose placing the nets at the site of the former Franklin Clubrooms as proposed.

Council has advised that it does not intend to remove contaminated materials (buried asbestos) from this site. It describes the site as rehabilitated. However, nets in this location would require significant excavation of materials to create a level surface with the oval.

The cricket nets would become the focus of the view to the river from the Huon Highway across the oval and from the vicinity of the Palais Theatre. This would negatively impact the amenity of residents and visitors and in years to come as the nets degrade would become an eyesore. It would also conflict with Key Recommendation 8 of the Corney Heritage Study which denotes this site as a nobuild area.

It would also be the waste of an opportunity to utilise this location for something that is visionary and long-lasting.

The nets have no other purpose and for most of the year would be unused.

The nets in this location would also require the removal of a large section of the historic velodrome. Although the surface has been deliberately degraded and neglected over a number of years, the track still receives some use. Removing a section of the banking would eliminate all use but would also confuse the interpretation of the site. No changes to the velodrome should be made without a supporting independent heritage assessment.

Although public use of the nets will be permitted they are being provided principally for the Southern Tigers Cricket Club. Use of the nets by the public will be restricted on every Saturday and most Sundays and on occasional weekdays during the cricket season as there will be conflict with matches being played on the oval.

The provision of cricket nets can be safely achieved without losing community amenity. Bellerive Oval practice wickets are external to the ground and alongside a busy road. Adelaide Oval practice wickets are also external to the ground and adjacent to other sporting facilities (tennis courts). The practice wickets at Huonville Oval and the Slab Road Oval are external to the ground.

The ideal location is immediately adjacent to the existing tennis court. (Note: expansion of the tennis courts towards the river cannot occur because of the presence of the water pipeline). An additional fence of the same length as for the

Meeting: 26.08.2020 Item Number: 19.018/20* Page 18 of 63 tennis court (35m) could be built parallel and 8m apart. There would be an internal fence of 20m to create two wickets and netting built above.

Built properly, the nets in this location would contain all balls.

These nets could be used by the Cricket Club and the community at all times.

Asbestos

Prior to any works at the site of the former clubrooms and regardless of the future agreed upon use, Council should completely remove all contaminated materials and remediate the site. Doing so would mean that the negative legacy is removed for future generations to deal with. It would also show that Council is a good 'citizen' and prepared to do what every member of the community also has to do. It will create an expense to Council but this will require local contractors and the benefit will remain locally.

Public Art

This is an ideal site for a high-quality piece of public art.

Former Clubrooms Scoreboard

Investigate the use of the former scoreboard in an historic interpretation of the site.

- Rowing Statue and panels no objection but should be a matter for the rowing club to pursue
- Asphalt removal I note that Southern Pedals previously proposed to fund an upgrade the surface of the track but Council preferred the track to degrade. However, the track is beyond retrieving and I reluctantly support the asphalt removal. However, the historic banking must be retained in its entirety.

- Handball court there should be a range of sports and games provided but the focus should not be just to concrete over the contaminated site. Could include public exercise equipment, etc.
- Tennis wall strongly opposed as it will be a solid barrier to the view along the foreshore. The only location that might work is behind the Bowls Club.

Master Plan Stage 3 Sporting Precinct.

The Franklin Progress Association is representative of a diversity of views on this matter.

There is broad agreement on a number of features of the proposed Plan and in particular that this area of Franklin is recognised as a sporting precinct.

There is broad agreement on increasing the range and of upgrading sporting facilities.

- There is broad agreement on the provision of upgraded cricket nets although the FPA does not have an agreed preferred location.
 However, in addition to the proposed site it is requested that Council also consider other locations for the nets including
 - 1. the north-east corner of the oval and
 - 2. immediately adjacent to the existing tennis court.

It is further requested that Council provides an in-house cost/benefit analysis to the community on each of these three sites.

- There is broad agreement on the requirement to remove the asphalt from the former velodrome. However, it is our preference that the entirety of the velodrome banking is retained.
- There is strong support for the provision of shade trees, benches and tables and of softening the surfaces in this precinct. It is noted that public art could also be included.
- There is strong support for the addition of interpretation panel(s).
- We note the limited use of the public toilets adjacent to the change rooms and recommend the provision of improved signage.
- We do not support the removal of access for vehicles along the foreshore.
- We do not support the provision of an Overhead Gateway Sign.
- There is a high degree of concern over the treatment of the asbestos
 presence. It is our view that prior to any works that all contaminated materials
 be removed and disposed of properly and the site be fully rehabilitated. If
 Council chooses not to do this then we request that it provides an in-house
 cost/benefit analysis of both options to the community

Proposed Franklin sporting precinct

Community consultation on the formalisation of a sporting precinct on part of the fore-shore at Franklin is now open at the Huon Valley Council (HVC) website.

The proposal has been developed in consultation with the sporting clubs that use the facilities, particularly the Southern Tigers Cricket Club, which was firmed when Franklin and Castle Forbes Bay Cricket Clubs amalgamated some years ago.

Two years ago, the Southern Tigers relinquished the lease of the Castle Forbes Cricket Club

quanta the lease of the Castle Forbert, Incore can and is now solely based at the Franklin Cabrooms. Since that time, the club has not had usable cricket nets, utilising the Huon Valley PCV-where possible, but club president Daniel Ford said that the new nets would be the highlight of the development.

"Back in the day, we could hit back out of the nets behind the tennis courts, because of where

the old clubrooms were, the balls would hit that," said Daniel

"But we can't use them now because the road grades towards the river, it means that every sin-gle cricket ball that comes out of those nets ends up in the water."

up in the water."

The new nets, along with a handball court, would be built over the site of the old clubrooms, a site which was used to bury asbestos when the clubrooms were demolished in controversial circumstances in 2009. HVC said, "There have been two independent

reports by suitably qualified personnel on this site regarding asbestos, and both of them confirmed there is no threat to the public from asbestos. "The site, however, does continue to be a

source of public concern. The cricket nets were identified as an element

to be included in this plan following ongoing dis-

cussions with the cricket club to upgrade the nets. "Having the cricket nets and the handball court covering the site would help alleviate com-

mity concerns."

Daniel said that the nets will be well-posi tioned to ensure that balls are hit back onto the

tioned to ensure that basis are into back onto the oval to reduce any risk of cars being hit, as well as saving balls from going into the river.

The proposal also includes a formalised gateway to denote the 'Franklin Sporting Precinet', signage to highlight the history of Franklin's cycling velodrome, football and cricket achievements, a formalised car park and removal of the asphalt surface of the velodrome, as well as re-moval of a section of the velodrome to allow a

run up into the new cricket nets.

There will also be picnic tables and a for-

alised walking trail.

The proposal is stage three of the Franklin

Foreshore Master Plan 2013 and follows on from stage one (the upgrade of the playground area in front of Petty Sessions) and stage two (the rowing finish line area).

Components of the plan are funded through the 2019/20 asset renewal budget, with \$117,000

available for the project.




- Promote the use of the Franklin foreshore area and support measures to increase community access to the foreshore creating a sporting precinct that can be enjoyed by the community.
- Improve pedestrian access from the existing walking track to the Franklin oval.
- Promote the area for event use including improvement of landscape amenity and facilities along the foreshore.
- Retain areas of established vegetation and ensure placement of new landscaping is consistent with existing use of the area and utilise indigenous species to the benefit of the long term health of the Franklin foreshore area.

- 1 Improve the visual amenity of the area by painting elements of the club rooms facing the walking track
- 2 Improve vehicle control by defining existing car parking areas around the Bowls and Tennis Club and restrict public vehicle access to the foreshore.
- 3 Section of the oval boundary will be removed to allow a run up into the new cricket practice nets and to facilitate easier pedestrian access to the oval.
- 7 'Franklin Sporting Precinct' large walk through gateway sign to define the area and display information about Franklins rich sporting heritage.
- 8 Interpretive signage to highlight the history of Franklin's cycling velodrome, football and cricket achievements. Liaise with the local clubs to gather information, images and stories that demonstrate the history of the area.
- 9 Install statue or interpretive sign celebrating the prolific rowing success that Franklin has fostered. Liaise with local rowing clubs and historians to develop interpretive signage panels to

FRANKLIN FOOTBALL OVAL PICNIC SITE

ASBESTOS CEMENT SHEET CONTAMINATION

1.0 INTRODUCTION

- 1.1 A number of Codes and Guidelines have been published over the years for Controlling Asbestos Hazards.
- 1.2 The last amendment issued by the National Occupational Health and Safety Commission was in 2005. It consisted of three parts, and was titled The Code of Practice for the Management and Control of Asbestos.
- 1.3 The Workplace Health and Safety Regulations, 1998, Division—9 Asbestos outlines the regulatory requirements.
- 1.4 The Code of Practice sets out the steps to be taken to eliminate or otherwise minimise the risk of exposure to airborne asbestos fibres, including the identification of asbestos, risk assessments and the implementation of control measures.

2.0 BACKGROUND

- 2.1 The Huon Valley Council demolished the Franklin Football Oval Clubrooms during 2009.
- 2.2 The Council covered the site with gravel, road base, that was graded at various Depths from 600 mm to 1.8 m.
- 2.3 A layer of 'scalpel' (red dust) was spread and made firm over the gravel.
- 2.4 The area was converted to a picnic area, for use by the community and tourists.
- 2.5 Unbeknown to the Council, the original building contained asbestos cement (AC) sheeting. When the building was demolished fragments of the AC sheeting were dispersed throughout the gravel and red dust. Some small pieces were found on the surface.

2.6 Following complaints of asbestos contamination, from one resident in particular, an inspection of the area was conducted on the 11 September 2009. The inspection revealed only several small fragments of AC sheet, these were collected for analyses.

3.0 EVALUATION AND RISK ASSESSMENT

- 3.1 At present the risk to the public's health is very low, due to the very small concentration of AC fragments on the surface. In addition, the asbestos fibres are fixed in a matrix of cement and are not airborne.
- 3.2 The concentration of airborne asbestos fibre is virtually negligible and the likelihood of exposure is correspondingly very low.
- 3.3 The health effects of airborne asbestos have been well documented and there are a number of consistent findings including:
 - the risk of acquiring each type of disease is dose related, ie the higher the concentration of dust and the longer the exposure the greater the chance of developing an asbestos related disease.
- 3.4 The background concentration of airborne asbestos fibre in the Main Street of Huonville would be higher than that at the Franklin Picnic area.

4.0 REVIEW

4.1 Although the Risk Assessment indicates that the health effects are low it would be prudent, considering it is to be used as a public facility, including children, to implement Control Measures.

5.0 CONTROL MEASURES

- 5.1 Scrape off approximately 100 mm of the "Red Dust". Load onto a truck and dump it at a designated, licensed tip. Inspect the scraped section to determine the amount of asbestos cement fragments remaining. Recover the surface with a fresh lot of "Red Dust" to 100mm.
- 5.2 Alternatively, if there is enough room, add 100 mm of "Red Dust" over the existing "Scalpel" and roll it firm.
- 5.3 In time the covered AC sheet fragments will soften and probably loosen from the Cement matrix.
- 5.4 Survey the site and record it as a designated asbestos area that is not to be disturbed.

6.0 RESPONSIBILITIES

- 6.1 The Huon Valley Council has the duty of care for the site.
- 6.2 The Council must develop and implement an asbestos management plan
- 6.3 Inspect the site frequently.
- 6.4 Develop and maintain an asbestos register.
- 6.5 Prevent access by undesirable persons, particularly in cars at night, by erecting a boom gate.
- 6.6 Inform workers or contractors who may be required to work in the area.
- 6.7 Inform Council employees of the health risks of asbestos.

7.0 CONCLUSION

- 7.1 As mentioned the site contains fragmented AC sheet. The risk to cause any adverse health effects is very low.
- 7.2 However, considering the picnic area will be used by people from the community and tourists, particularly children, every effort must be made to completely cover the area.
- 7.3 The Huon Valley Council must develop a Management Plan for the site.
- 7.4 Survey details should also be lodged with the Department of Environment.

Introduction

A meeting was held on 2 December 2009 at Huon Valley Council Offices between Mike Dowling of Mike Dowling Industrial Pty Ltd and Huon Valley Council officer, Mark Dance. The purpose of the meeting was to discuss the possibility of producing an Asbestos Control Plan for the Franklin Picnic Oval Area.

Prior to being demolished in early 2009, there were weatherboard football club rooms on this site. During the demolition, some asbestos cement sheeting was apparently mixed up in the demolition debris (reportedly unbeknownst to the Council). Fragments of the asbestos cement sheet remained after demolition and removal of building debris, dispersed across the demolition site. The demolition site containing fragments of asbestos cement sheet was reportedly covered with gravel road base (reportedly 0.6 to 1.8m depth) and top layer of 'red metal dust'.

The former demolition site was converted to a public picnic area. However, it was subject to trespassers in vehicles that scarred the gravel surface (reportedly doing 'wheelies' and skidding on the gravel). At least one person has come forward to present the Council with a piece of asbestos cement sheet recovered from the demolition site. There was concern expressed about public health if persons could be exposed to soil containing such fragments of cement sheet.

Huon Valley Council proceeded to install two wooden picnic tables in the gravel area for public use, spaced around the centre of the gravel area for the purpose of deterring vehicle access to trespassers. During the digging of the foundation holes for the picnic tables, more fragments of asbestos cement sheeting were observed. After installation of the picnic tables was completed, additional red metal dust was placed around them.

The Council engaged Michael Curtain, an Occupational Hygienist, to review the asbestos contamination of the site and recommend risk-based control measures (Attachment 1). Mr Curtain recommended removal of the top layer of red metal dust to a depth of 100mm, and replacement of the top layer with 100mm of uncontaminated red metal dust. His report recommends long-term surveillance of the site and recording the contamination issues to prevent inadvertent exposure to Council workers or the public in the future.

Mike Dowling conducted a visual inspection of the site on 2 December 2009 and did not identify any discernible evidence of asbestos cement sheet on the surface of the former demolition site.

Scope of this review

Mike Dowling Industrial engaged Richard Stoklosa of E-Systems Pty Limited to undertake an independent 'desktop' review of the circumstances of asbestos contamination of soil (gravel and red metal dust). The scope of this review is to assess the risk of exposure, identify guidance for decontamination of soil from relevant documents, and recommend options for a control plan to prevent potential health risks to Council workers and the public.

E-Systems has not inspected the contaminated site, and the analysis and advice presented here relies on observations that have been reported, as detailed in this review. E-Systems understands that the subject property is owned by the Huon Valley Council for public land use.

e-systems

Risk of exposure

Contamination source

Although the depth of the gravel covering of the former demolition site is reported to be at least 0.6m depth, up to a maximum of 1.8m depth, at least one person has reportedly discovered a single fragment of asbestos cement sheet. It is possible that fragments of asbestos cement have been mixed with the imported gravel and red metal dust that was placed on the site by construction vehicles and workers.

The quantity and extent of the contaminated soil has not yet been determined. To assess the risk, it will be necessary to delineate the contamination by field examinations of small excavations around the perimeter of the demolition site. Methods for soil sampling are outlined in enHealth (2005), Western Australia Department of Health (WADOH 2009). The objective of soil sampling would be to determine the concentration by weight of asbestos-containing materials (ACM, such as fragments of asbestos cement sheet) by visual screening and collection of fragments. A visual screening procedure would not include the concentration by weight of fibrous asbestos and asbestos fines that might be present in the sample.

Friable asbestos materials, such as cement sheet, are recognised sources of airborne asbestos fibres when exposed and disturbed by handling, vibration and wind. Laboratory methods to create respirable dust from a soil sample are prohibitively expensive (reportedly over \$1,000 per sample with an error range of plus or minus 50 percent). Therefore, it is not practical to conduct laboratory testing of soils to characterise the asbestos hazard for a risk assessment.

Alternatively a precautionary assumption can be made that contamination extends throughout the entire demolition site where construction debris is covered by gravel and red metal dust, and that the entire depth profile is contaminated. Such an assumption may overstate the quantity of contaminated soil, leading to an estimation of very high excavation and disposal costs if all of the contaminated material was to be removed (refer to 'Recommended control options' heading below).

Over time, the friable asbestos cement sheet may weather in situ, and perhaps soften to release smaller fragments and fibrous material. These small fragments may be less dense than the surrounding soil material, but whether they are 'buoyant' enough to eventually reach the surface depends on the integrity of the gravel layer covering the site. Shallow groundwater or saturation of the former demolition area from stormwater runoff may increase the mobility of the buried asbestos fragments, potentially raising them to the surface of the gravel over time. However, such mobilisation and release of asbestos fibres to the atmosphere under these conditions would be expected to be so small as to be non-detectable.

Future development or installation of services on the site may also expose asbestos fragments to the atmosphere. Such development may include trenching to install underground services or water reticulation, or installation of lamp posts, fences and bollards.

Exposure standards

Guidance for the control of asbestos in workplaces in Tasmania is guided by Codes of Practice (NOHSC 2005a, 2005b), and Exposure Standards (NOHSC 1995). The guidelines for workplaces are considered more stringent than the exposure standards generally accepted by health authorities for public open space. Exposure in the workplace is based on adults present for full-time workdays, compared to relatively infrequent use of open space (picnic and recreational area) by the public. However, the workplace exposure standards do not consider exposure to children or those non-workers who might be more vulnerable to exposure.

Soil asbestos investigation criteria is available to determine whether contaminated land should be subject to remediation. A target concentration of asbestos in air of less than 0.1 fibres per millilitre (f/mL) is generally used to set investigation criteria, consistent with workplace exposure standards (NOHSC 1995). It has been shown that asbestos concentration in air is unlikely to occur above 0.1 f/mL where 5 mg/m³ of respirable dust is generated from dry soil containing 0.001 percent asbestos. These findings are used to guide the soil investigation criteria

enHealth (2005) recommends a limit of 0.001 percent by weight asbestos in soil, to control airborne asbestos to a level that is considered 'acceptable risk' by public health authorities (a lifetime incremental cancer mortality of 10⁻⁶ to 10⁻⁵ in the exposed population). WADOH (2009) reviewed research by Swartjes and Tromp (2008) to develop a limit of 0.02 percent by weight of asbestos-containing materials (ACM) for 'parks, public open spaces, playing fields, etc'. However, WADOH has accepted the limit of 0.001 percent by weight asbestos criteria for fibrous asbestos and asbestos fines, consistent with the ehHealth investigation criteria.

Asbestos cement sheet contains about 15 percent by weight asbestos. The fragments the might be recovered from soil sampling and a visual screening process could be used to determine the weight percentage of asbestos in soil; however, this result would not include asbestos fibres that may have been liberated from the cement sheet matrix which are not detectable in a visual screening process.

Risk analysis

The risk of exposure to the public at this site is currently informed by the discovery of a single fragment of asbestos cement sheet. If the WADOH (2009) investigation criteria of 0.02 percent by weight of ACM is adopted for public open space, and we accept a calculation by 'Pickford (2001)' (referenced in Parsons Brinckerhoff 2008):

"...soil or aggregate of one square metre horizontal area and one metre deep could contain 167 asbestos-cement pieces, $40 \times 40 \times 6$ mm, yet still only contain 0.001% of asbestos by weight,

then, a one cubic metre area of the subject open space would have to contain about 20 times the 167 pieces to reach the 0.02 percent by weight investigation criteria, or about 3,300 asbestos-cement pieces in one cubic metre of soil exposed at the surface of the ground. This does not account for loose asbestos fibres that may also be present in the soil from decomposition and weathering of asbestos fragments.

Although the calculation has not been independently verified by weighing samples of asbestos cement sheet, it suggests that a very large quantity of asbestos would have to be present in the soil to present a potential exposure risk to workers or the public. Only a sampling program to visually screen the soils and quantify the amount of asbestos present would enable the risk to be characterised.

Objectives for control strategy

The objective for control of asbestos on the former demolition site, now public open space, is to achieve a standard of no visible asbestos on the site. The selected control strategy should result in a very low likelihood of asbestos fragments being discovered by the public. In doing so, the risk of airborne asbestos fibres is expected to be below the exposure standards generally accepted by health authorities, and below any background levels of airborne asbestos from other potential sources at this site.

e-systems

The hierarchy of control strategies for asbestos is (NOHSC 2005a):

- 1. Elimination or removal of asbestos-containing material and fibres, which is the most preferred control strategy;
- 2. Isolation, enclosure or sealing of the asbestos in-situ;
- 3. Engineering controls to prevent release or exposure;
- 4. Safe work practices to avoid encountering the asbestos, based on administrative controls; and
- 5. Personal protective equipment, which is the least preferred control strategy.

Recommended control options for consideration by the Council

The options for controlling the exposure of Council workers and the public are discussed in terms of the hierarchy of control strategies. These are presented for consideration by the Huon Valley Council to reduce potential health risks to acceptably low levels, and to address the objective of no visible asbestos on the site. The selection of control strategies that do not include removal of the contamination may require consultation to meet the expectations of stakeholders.

Elimination (most preferred control strategy)

Removal of the contaminated soil will require further investigation to determine the areal extent and depth of contaminated soils. Delineation of the demolition and fill material by visual examination of test pits will be the most cost effective means of determining the volume of material to be removed and disposed of as hazardous waste (under license by environmental authorities). Elimination of the contaminated soils is a final solution, not requiring any of the other control strategies that might otherwise by used.

The removal of contaminated soils must be managed under strict procedures and using specialised equipment to prevent exposure to workers and the dispersion of asbestos from the job site into the air. Monitoring of the job site will be necessary to verify compliance with occupational exposure standards. Planning for such a project must refer to relevant NOHSC publications (NOHSC 1995, 2005a and 2005b), the Tasmanian Workplace Health and Safety Regulations (1998). The procedures should also be developed using the advice contained in enHealth (2005) and WADOH (2009).

Sealing of the asbestos in situ

The covering of the site with gravel and red metal dust will continue to prevent fragments of asbestos cement sheet from appearing at the surface, as long as the cover materials are carefully placed to avoid mixing with asbestos-contaminated soils. Imported soils should be tested for evidence of contamination (if necessary) to verify that any background levels of heavy metals and chemical compounds are below the accepted investigation levels for public open space.

Loose gravel may shift over time, requiring maintenance and re-compaction to prevent movement of lower density asbestos fragments to the surface where they may be discovered by public users of the area. A prescribed maintenance plan is necessary

An additional barrier of vegetation (eg grasses, landscaping) is recommended to provide a compatible top seal on the area for public open space use. The irrigation and maintenance of vegetation will be necessary to ensure that root systems bind and stabilise the soils used to cover the site.

Sealing of the asbestos in situ also requires engineering controls and administrative arrangements, as described below.

Engineering controls to prevent release or exposure

The erection of barriers to vehicular traffic on the area of contamination will prevent the area from being scoured by tyres and eroding to reveal asbestos fragments below the uncontaminated soils used to cover and seal the asbestos below ground level.

Reticulation and automated irrigation of any vegetation established on the property will make this type of cover material an effective long-term barrier.

Administrative arrangements to avoid accidentally encountering asbestos

On-site containment of asbestos through sealing it in situ, and using appropriate engineering controls to prevent degradation of the sealed surface should only proceed if the subsurface contamination is appropriately recorded in land title, planning and maintenance records for the property. These records and administrative controls to prevent accidental exposure must be enforceable.

An example of enforceable administrative controls is a permit to work system for any land disturbance on the property, which considers the need for dust suppression and PPE with regard to exposure to asbestos-contaminated soils.

Personal protective equipment (PPE)

The use of PPE is clearly not applicable to public users of the site. Other controls must be adopted to prevent exposure of workers to asbestos-containing materials as described above.

Council workers and contractors, however, should always consider the need for appropriate PPE when maintaining or developing the property where land disturbance is being contemplated. Guidance for appropriate PPE can be found in the Code of Practice for the Management and Control of Asbestos in Workplaces (NOHSC 2005a).

Conclusions

The advice presented here is based on information provided by Mike Dowling Industrial and Mike Curtain, Occupational Hygienist (Attachment 1). E-Systems has not inspected the subject property and advice presented here is subject to clarification pending further investigation of the circumstances of reported asbestos soil contamination.

- 2.1 The Huon Valley Council demolished the Franklin Football Oval Clubrooms during 2009.
- 2.2 The Council covered the site with gravel, road base, that was graded at various Depths from 600 mm to 1.8 m.
- 2.3 A layer of 'scalpel' (red dust) was spread and made firm over the gravel.
- 2.4 The area was converted to a picnic area, for use by the community and tourists.
- 2.5 Unbeknown to the Council, the original building contained asbestos cement (AC) sheeting. When the building was demolished fragments of the AC sheeting were dispersed throughout the gravel and red dust. Some small pieces were found on the surface.

2.6 Following complaints of asbestos contamination, from one resident in particular, an inspection of the area was conducted on the 11 September 2009. The inspection revealed only several small fragments of AC sheet, these were collected for analyses.

3.0 EVALUATION AND RISK ASSESSMENT

- 3.1 At present the risk to the public's health is very low, due to the very small concentration of AC fragments on the surface. In addition, the asbestos fibres are fixed in a matrix of cement and are not airborne.
- 3.2 The concentration of airborne asbestos fibre is virtually negligible and the likelihood of exposure is correspondingly very low.
- 3.3 The health effects of airborne asbestos have been well documented and there are a number of consistent findings including:
 - the risk of acquiring each type of disease is dose related, ie the higher the concentration of dust and the longer the exposure the greater the chance of developing an asbestos related disease.
- 3.4 The background concentration of airborne asbestos fibre in the Main Street of Huonville would be higher than that at the Franklin Picnic area.

4.0 REVIEW

4.1 Although the Risk Assessment indicates that the health effects are low it would be prudent, considering it is to be used as a public facility, including children, to implement Control Measures.

5.0 CONTROL MEASURES

- 5.1 Scrape off approximately 100 mm of the "Red Dust". Load onto a truck and dump it at a designated, licensed tip. Inspect the scraped section to determine the amount of asbestos cement fragments remaining. Recover the surface with a fresh lot of "Red Dust" to 100mm.
- 5.2 Alternatively, if there is enough room, add 100 mm of "Red Dust" over the existing "Scalpel" and roll it firm.
- 5.3 In time the covered AC sheet fragments will soften and probably loosen from the Cement matrix.
- 5.4 Survey the site and record it as a designated asbestos area that is not to be disturbed.

6.0 RESPONSIBILITIES

- 6.1 The Huon Valley Council has the duty of care for the site.
- 6.2 The Council must develop and implement an asbestos management plan
- 6.3 Inspect the site frequently.
- 6.4 Develop and maintain an asbestos register.
- 6.5 Prevent access by undesirable persons, particularly in cars at night, by erecting a boom gate.
- 6.6 Inform workers or contractors who may be required to work in the area.
- 6.7 Inform Council employees of the health risks of asbestos.

7.0 CONCLUSION

- 7.1 As mentioned the site contains fragmented AC sheet. The risk to cause any adverse health effects is very low.
- 7.2 However, considering the picnic area will be used by people from the community and tourists, particularly children, every effort must be made to completely cover the area.
- 7.3 The Huon Valley Council must develop a Management Plan for the site.
- 7.4 Survey details should also be lodged with the Department of Environment.

OVERALL DESIGN INTENT

The Franklin foreshore area has been a focal point for rowing, cricket, football, cycling and other sports since the 1800s and is strongly linked with the early history of Franklin's settlement and the development of the Huon Valley.

- Improve the visual amenity of the area by painting elements of the Tennis club rooms facing the walking track.
- 2. Improve vehicle control by defining existing car parking areas around the Bowls and Tennis Club and restrict public vehicle access to the foreshore. 9.
- 3. Existing Franklin cenotaph to be relocated to a more suitable location in the future.
- Interpretive signage to highlight the history of Franklin's cycling velodrome, football and cricket achievements. Liaise with the local clubs to gather information, images and stories that demonstrate the history of the area.
- Install statue or interpretive sign celebrating the prolific rowing success that Franklin has fostered.
 Liaise with local rowing clubs and historians to develop interpretive signage panels to demonstrate the sporting history of the area.
